## 1. Scope of Application

Licensors is PRIVREDNO DRUŠTVO ZA KONSALTING I MENADŽMENT POSLOVE GOPRO DOO BEOGRAD (ZEMUN) [CONSULTING AND MANAGEMENT COMPANY GOPRO LTD BELGRADE (ZEMUN)] (“GoPro d.o.o.”), with registered seat in Belgrade, Zemun, 27c Prve Pruge St, Serbia.

This EULA applies to all standard Company’s software programs, products, contents, functionalities including new versions (upgrades, updates, service packs or hotfixes) (“Software”).

The Contract Software together with documentation and accompanying documents, is copyrighted. Contrary-to-contract use, in particular any distribution, wired or wireless communication to the public, including making publicly available, transmission, modification and reproduction are illegal and will be prosecuted under criminal and civil law.

## 2. License

By receiving, opening the file package, and/or using this Software, you agree that this End User License Agreement (EULA) is a legally binding and valid contract and agree to be bound by it. You agree to abide by the intellectual property laws and all of the terms and conditions of this EULA. Your use of Software indicates your acceptance of this EULA and warranty. Subject to the terms of this EULA, GoPro d.o.o. grants to you a limited, non-exclusive, non-transferable license, without right to sub-license, to use Software in accordance with this EULA and any other written agreement with GoPro d.o.o.. GoPro d.o.o. does not transfer the title of Software to you; the license granted to you is not a sale. This EULA is a binding legal agreement between GoPro d.o.o. and the Buyers or users of Software. If you do not agree to be bound by this EULA, remove Software from your computer now and, if applicable, promptly return to GoPro d.o.o. by mail any copies of Software and related documentation and packaging in your possession.

Software and the license herein granted shall not be shared, copied, distributed, publicly reproduced by wire or wireless means, made publicly available, rented, leased, re-sold, offered for re-sale, transferred or sub-licensed in whole or in part except that you may make one copy for archive purposes only. For information about redistribution of Software contact GoPro d.o.o..

## 3. User Agreement

Your license to use Software is limited to the number of licenses purchased by you. You shall not allow others to use, copy or evaluate copies of Software.

## 4. Use Restrictions

You shall use Software in compliance with all applicable laws and not for any unlawful purpose. Without limiting the foregoing, use, display or distribution of Software together with material that is pornographic, racist, vulgar, obscene, defamatory, libelous, abusive, promoting hatred, discriminating or displaying prejudice based on religion, ethnic heritage, race, sexual orientation or age is strictly prohibited. Each licensed copy of Software may be used on one single computer location by one user. Use of Software means that you have loaded, installed, or run Software on a computer or similar device. If you install Software onto a multi-user platform, server or network, each and every individual user of Software must



be licensed separately. You may make one copy of Software for backup purposes, providing you only have one copy installed on one computer being used by one person. Other users may not use your copy of Software. The assignment, sublicense, networking, sale, or distribution of copies of Software are strictly forbidden without the prior written consent of GoPro d.o.o.. It is a violation of this EULA to assign, sell, share, loan, rent, lease, borrow, network or transfer the use of Software. If any person other than yourself uses Software registered in your name, regardless of whether it is at the same time or different times, then this EULA is being violated and you are responsible for that violation.

## 5. Restriction of Copyright

## 9. Data Usage Consent

You agree that GoPro d.o.o. may collect and use information gathered in any manner as part of the product support services provided to you, if any, related to Software. GoPro d.o.o. may also use this information to provide notices to you which may be of use or interest to you.

## 10. Governing Law

This EULA shall be governed by the law of the Serbia applicable therein. You hereby irrevocably attorn and submit to the non-exclusive jurisdiction of the courts of Serbia therefrom. If any provision shall be considered unlawful, void or otherwise unenforceable, then that provision shall be deemed severable from this License and not affect the validity and enforceability of any other provisions.

## 11. Termination

Any failure to comply with the terms and conditions of this EULA will result in automatic and immediate termination of this license. Upon termination of this license granted herein for any reason, you agree to immediately cease use of Software and destroy all copies of Software supplied under this EULA. The financial obligations incurred by you shall survive the expiration or termination of this license.
